

CONSENT AND ASSIGNMENT

This Consent and Assignment (the "Assignment") is effective when signed by the undersigned, writer ("Writer") and is between Writer and Chelsea Foundation (collectively, the "Parties") or between artist ("Illustrator") and is between Illustrator and Chelsea Foundation, (collectively, the Parties). For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree:

1. Chelsea Foundation gratefully acknowledges the contribution Writer/Illustrator is hereby making to Chelsea Foundation of the original work product (the "Work") created, developed, worked on, or revised by Writer/Illustrator in connection with Chelsea Foundation's newsletter, website, and other activities and services (the "Project"). So that Chelsea Foundation may fully use the Work in any manner it sees fit, including making copies, modifications, and derivative works, Writer/Illustrator hereby fully and unconditionally transfers, assigns, and conveys to Chelsea Foundation, its licensees, successors, and assigns (collectively, "CF"), all of Writer's/Illustrator's copyright ownership interests and other intellectual property rights in the Work (collectively, the "Intellectual Property Rights"). Nothing herein constitutes an obligation by CF to make any use of the Work or any portion of the Work.

2. Writer/Illustrator declares that he or she is the author/illustrator or sole claimant of the copyright or other intellectual property rights in and to the Work, and Writer/Illustrator hereby releases, holds harmless, and indemnifies CF from any and all infringement claims and other claims based on the Work. Writer/Illustrator further agrees that CF may publicly recognize and acknowledge Writer's/Illustrator's contribution to, and involvement in, the Project by including Writer's/Illustrator's name (or any fictional name), picture, portrait, likeness, or photograph in the Project.

3. This Assignment is governed by Georgia law, can only be amended if both Parties do so in writing, is assignable solely by CF, and supersedes any contrary oral or written agreement or understanding. Writer acknowledges that he or she is at least eighteen (18) years old, has read this Assignment and is fully familiar with its contents, and is competent to contract on behalf of him or herself. Writer/Illustrator grants to CF the power and authority to execute any documentation deemed necessary by CF to register or protect the Work or Intellectual Property Rights therein or complete the full transfer of the Work and Intellectual Property Rights to CF, which is the purpose of this Assignment.
